**TERMS AND CONDITIONS**

1. Information on how to enter and the prize(s) form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. Entrants are only open to Australian residents aged 18 years or over.
3. Employees (and their immediate families) of the Promoters, and agencies associated with this promotion are ineligible to enter. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1<sup>st</sup> cousin.
4. Promotion begins at 9:00 am on Monday 12 January 2026 and closes at 8:00 pm on Wednesday 28 January 2026 or until allocation of prizes is exhausted, whichever occurs first.
5. To be eligible, individuals must complete the following steps during the Promotional Period:
  - a. Make one or more purchases of \$10 that are Eligible Transactions. An "Eligible Transaction" is a transaction made by an entrant who makes a purchase at a Level 3 Food Court Retailer during the Promotion Period.
  - b. Scan the QR code at the Level 3 Food Court point of sale or the Promotion Desk (located in the Level 3 Food Court) and complete all the fields on the form and submit to the centre database;
  - c. Show the completed confirmation screen and their receipt to the staff at the Promotion Desk in the Level 3 Food Court to receive a free voucher.
  - d. Only the first 1,600 customers will each be awarded the promotional prize outlined below, until allocation is exhausted.
6. The Promoters reserve the right, at any time, to verify the validity of entries and entrants (including an entrant's identity, age and place of residence) and reserves the right, in its sole discretion, to disqualify any individual who the Promoters have reason to believe has breached any of these Terms and Conditions, tampered with the entry process or engaged in any unlawful or other improper misconduct calculated to jeopardise fair and proper conduct of the promotion. The voucher cannot be used in conjunction with any other voucher. The voucher can be redeemed in the Level 3 Food Court up until 8pm on Wednesday 28 January 2026. A maximum of 3 vouchers per person, per day can be given by the Promotion Desk.
11. The Promotion Prize can only be redeemed for the items listed on the voucher. Participating Level 3 Westpoint Food Court retailers include: Kochi, Cobb & Co, Taco Bell, Yatai Express, Milk Flower, Oporto, Lanzhou Beef Noodles, Yogurberry. McDonalds, KFC. The Level 3 Food

Court retailers may be open during the promotional period and store participation may vary. The voucher is not valid for Level 4 Food Retailers and not valid for Level 1 Food Retailers. The free kids meal voucher is restricted to the meal items in the table below:
