WESTPOINT Black Friday IMAX Gift with Purchase

TERMS AND CONDITIONS

- 1. Information on how to enter and the prize(s) form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
- 2. Entrants are only open to Australian residents aged 18 years or over.
- 3. Employees (and their immediate families) of the Promoters, and agencies associated with this promotion are ineligible to enter. Immediate family means any of the following: spouse, exspouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1st cousin.
- 4. Promotion begins at 9:00 am on Friday 28 November 2025 and closes at 5:00 pm on Friday 12 December 2025 or until allocation of prizes is exhausted, whichever occurs first.

- 12. One voucher can be used in 1 transaction only. The voucher cannot be used in conjunction with any other voucher. A maximum of 3 vouchers per person, per day can be given.
